To appropriately code a chart for billing, the patient must meet certain criteria for diagnosis of Class 1, 2, or 3 Obesity. By providing a standardized location and content of current BMI status and Obesity Class, streamlining communication between care members occurs. Nurse documentation of a BMI status assessment populates in the provider's Admission, Transfer, and Discharge Summary Notes.

Nursing Assessment Documentation

- Obesity Class Documentation
 - The Height/Weight/Allergy Record form fires when • entering a patient's chart in Care Compass.
 - The Height/Dosing Weight form is found within the Admission MPage.
 - Each form shows the criteria needed to **document** Obesity Class and satisfy BMI capture.

Documenting Criteria \geq

- Enter the Height and Dosing Weight to calculate the BMI.
- Select Yes or No to document Is the patient less than 18 or pregnant?
 - Selecting No populates the Current BMI Status.
 - Selecting Yes does not populate any further fields.
- If the patient's BMI Status falls within **Class 1**, **2**, or **3** Obesity, the Attestation prepopulates.
- Current BMI Status populates to the provider's Admission, Transfer and Discharge Summary.
- Sign the form using the green checkmark.

Provider Documentation

The Attestation populates to the provider's Admission, Transfer and Discharge Summary for patients with a Class 1, 2, or 3 Obesity.
