



## Table of Contents Update – PowerChart & FirstNet

On **Tuesday, April 9**, updates to the **Table of Contents** or **Menu** will continue in **PowerChart** and **FirstNet**. The order of the links will be updated to streamline the content order and increase efficiency in locating the available links. The change will occur over several weeks. **Provider positions** will be the first to experience the updated Table of Contents.

### What is not changing?

- **No** links are being added or taken away.

### What will be changing?

- The first section will remain the same.
- The second section will be expanded to include **Patient Schedule** and **Telehealth**.
- The third section will be in alphabetical order.

### What if my Table of Contents/Menu is not divided into sections?

- The menu will be divided into three sections mimicking similar positions if there is a large number of links in the menu.
- The top section will contain links that are currently at the top now.
- Some menus will only be alphabetized.
